SKN-72XX SECURITY PACKAGING TAPE

Self-adhesive security packing tape for paper surface and cartons. When peeled this tape reveals a void warning message, thus clearly emphasising any attempt of entry. Suitable for sealing envelopes, cartons and boxes. Standard roll sizes can be used in hand dispensers for packaging tape with a sharp blade. For machine application long length rolls are available up to 500m.

APPLICATION

For high value or sensitive goods in transit and storage. The SKN-72 is aimed at high volume packaging applications and FMCG where security or confidentiality are paramount. Typically pharmaceutical, cosmetics, electronics and garments.
